By accessing or using the services offered on this website (“Services”), including short-term furniture hire, relocation support, delivery and collection, you (“Client”, “you”, “your”) agree to be bound by the following Terms & Conditions (“Terms”). If you do not agree with these Terms, you must not use our Services.

1. Acceptance of Terms

1. These Terms constitute a binding legal agreement between you and Relocation Hire Perth.
2. Your Order and our issuance of a written Order Confirmation form the contract for the supply of Services.

2. Definitions

1. “Order” means your booking request accepted by Relocation Hire Perth in writing.
2. “Hire Period” means the period from delivery of hired items to their collection.
3. “Furniture” means all items you hire through this service.
4. “Delivery” and “Collection” mean placement and removal of Furniture or goods at your nominated location.

3. Booking & Confirmation

1. All bookings are subject to item availability.
2. A contract only exists once we issue an Order Confirmation.

4. Hire Period

The Hire Period begins on the Delivery date/time and ends on the Collection date/time confirmed in your Order.

5. Fees & Payment

1. You agree to pay all hire, relocation, delivery, collection, and additional charges shown in your Order Confirmation (“Fees”).
2. All amounts are quoted in Australian Dollars (AUD) and include GST where applicable.
3. Payments must be made by the due date specified in your Order Confirmation.

6. Delivery & Collection

1. You must provide accurate delivery and collection details.
2. Delivery and collection times are estimates. We will make reasonable efforts to meet scheduled times but are not liable for delays beyond our control.
3. You must ensure safe, unobstructed access for delivery and collection personnel.

7. Use & Care of Hired Items

1. You must use hired items responsibly and for their intended purpose only.
2. You are responsible for all loss, damage, or theft of items during the Hire Period (excluding fair wear and tear).
3. You must not alter, relocate, resell, or dispose of hired items without written consent from Relocation Hire Perth.

8. Cleaning & Condition

1. Items are supplied clean and in good condition.
2. You must return items in substantially the same condition, subject to fair wear and tear.

3. Additional cleaning or repair charges may apply if items are returned excessively soiled or damaged.

9. Cancellation & Changes

1. Cancellation charges may apply
2. We may cancel or modify your Order due to inventory availability, operational issues, or force majeure, and will refund any prepaid amounts for cancelled services.

10. Risk & Ownership

1. Risk of loss or damage to hired items passes to you upon Delivery and remains with you until Collection.
2. Title and ownership of all hired items remain with Relocation Hire Perth at all times.

11. Liability & Indemnity

1. To the maximum extent permitted by law, our total liability for any loss or damage arising from these Terms is limited to the amount of Fees paid by you.
2. We are not liable for indirect, special, or consequential loss.
3. You indemnify Relocation Hire Perth against all claims, losses, damages, costs, and expenses arising from your use of the Services, breach of these Terms, or negligence.
